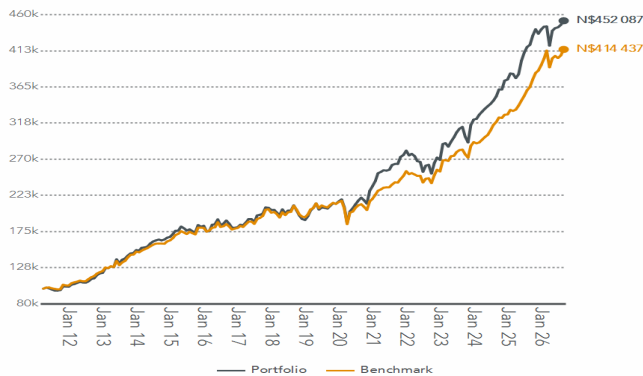

Advice Costs
